



**Release of Liability, Indemnification and Hold Harmless Agreement

I understand and acknowledge that horseback riding is a sport and that working with horses carries inherent risks of injury and damage to horse, property and my self.

I knowingly assume all risks, whether known or unknown of handling, being around and riding horse.

I hereby release M. Dennis Barwick (hereafter referred to as Property Owner) and The BackStretch (hereafter referred to as TBS) operating at 18500 Rea Ave., Aroma, California, and _____ (hereafter referred to as Trainer/ Instructor) from all Liability for any act of negligence or want of ordinary care on the part of Property Owner and/or Trainer/Instructor.

In consideration of my participation in Volunteer activities, events organized or sponsored by TBS, I waive, release and discharge the Property Owner , the Trainer/Instructor, their heirs, executors, and assigns from any and all claims if liability for injury or damage to myself , my animals or my property arising out of any and all claims of liability for injury or binding upon my heirs, executors, and assigns.

I expressly waive any rights I may have under California Civil Code 1542, which states: “A general release does not extend to claims which the creditor does not know or suspect to exist in his favor at the time of executing the release, which if know by him might have materially affected his settlement with the debtor.”

I agree that I will indemnify and hold harmless the property owner and or the trainer against all claims, demands and causes of action, including court costs and actual attorney fees, arising from any proceeding or lawsuits brought by or prosecuted for my benefit, in which this release is upheld.

The property owner and or trainer shall not be liable for any damage which may accrue from any cause or as a result of fire, theft, mining away, state of health, injury to person, horse or property.

Furthermore, I understand that from time to time, photos will be taken of participants, the participant’s horses and the participant’s family during events. I do hereby give consent to the property owner and or his trainer, without limitation, to publish and use such pictures and or stores for public relations purposes related to events participated in by the participant, without consideration of compensation of any kind and do hereby release said property owners and or the trainer from any claims whatsoever which might arise in said regard.
